

KIWI MANAGER END USER LICENSE AGREEMENT

This End User License Agreement - hereinafter referred to as AGREEMENT - is a legal agreement between you (either individual or entity) - hereinafter referred to as LICENSEE - and Sphere Concepts LLC for the use of Kiwi Manager, its parts, code, associated media or printed materials, and any online or electronic documentation. For the purpose of this AGREEMENT, Kiwi Manager will be referred to as SOFTWARE. By installing, copying, or otherwise using the SOFTWARE, the LICENSEE agrees to be bound by the terms of this AGREEMENT. If the LICENSEE does not agree to the terms of this AGREEMENT, the LICENSEE must remove the SOFTWARE and destroy all copies.

Software License

The SOFTWARE is protected by copyright laws and international treaties, as well as other intellectual property laws and treaties. The SOFTWARE is licensed, not sold. Sphere Concepts LLC owns title, copyright, and other intellectual property rights in the SOFTWARE. All violators will be pursued to the fullest extent allowed by the current Laws.

The foregoing limited warranty is the only warranty made by Sphere Concepts LLC and its affiliates and states the sole and exclusive remedies for Sphere Concepts LLC, its affiliates or suppliers' breach of warranty. Except for the foregoing limited warranty and any warranty, condition, representation or term to the extent, the same cannot or may not be excluded or limited by Law applicable to the LICENSEE in its jurisdiction. Sphere Concepts LLC and its affiliates provide the SOFTWARE and access to any websites, online services and CD services AS IS and with all faults and expressly disclaim all other warranties, conditions, representations or terms, express or implied, whether by statute, common Law, custom, usage or otherwise as to any matter, including but not limited to performance, security, non-infringement of third party rights, integration, merchantability, quiet enjoyment, satisfactory quality, or fitness for any particular purpose.

Duration of License

The LICENSEE is granted the right to use the SOFTWARE with no limitation of time as long as the LICENSEE is not in violation of any of the terms and clauses of this AGREEMENT. In the event of violation, all rights granted herein will be revoked immediately. Moreover, the LICENSEE shall proceed with the removal of the SOFTWARE and destroy any copies.

Grant of License

This AGREEMENT grants the LICENSEE the following limited, non-exclusive, and non-transferable rights, subject to all terms and conditions of this AGREEMENT. Under this AGREEMENT the LICENSEE is granted the right to install and run the SOFTWARE for its intended purpose. The LICENSEE is prohibited from using the SOFTWARE for purposes other than its intended use.

The LICENSEE is expressly not granted the right to copy, distribute, or resell the SOFTWARE, or any of its parts as stand-alone components, or as part of other software the LICENSEE may acquire, purchase, or develop. Violation of this clause will result in a breach of this AGREEMENT and consequent legal action from Sphere Concepts LLC for loss of profit for a minimum of \$250,000 to the fullest extent allowed by the Laws.

Under this AGREEMENT, the LICENSEE is permitted to make back up copies of the SOFTWARE files for re-installation in the event of permanent loss of data or unrecoverable system failure. Backup copies are subject to the same terms and conditions of this AGREEMENT.

The SOFTWARE is subject to the following restrictions:

Under this AGREEMENT, the LICENSEE is granted the use of the SOFTWARE provided that (a) the LICENSEE does not use Sphere Concepts LLC name, logo or trademarks without the written consent of Sphere Concepts LLC; (b) always include the copyright notice for the SOFTWARE; (c) agree to indemnify, hold harmless, and defend Sphere Concepts LLC, its suppliers and resellers, from and against any claims or lawsuits, including attorney's fees that may arise from the use of the SOFTWARE; (d) do not distribute, rent, lease, resell, bundle, wrap, or subclass the SOFTWARE as a stand-alone application or a component of a separate application.

Sphere Concepts LLC reserves all rights not expressly granted to the LICENSEE in this AGREEMENT.

Description of Other Rights and Limitations

You may not reverse engineer, disassemble the SOFTWARE, except and only to the extent that applicable law expressly permits such activity notwithstanding this limitation.

Bundled Software

Certain portions of the SOFTWARE are covered by separate licenses unless otherwise noted. Such licenses are included in their respective folders within the SOFTWARE.

No Liability for Consequential Damages

To the maximum extent permitted by applicable law, in no event shall Sphere Concepts LLC be liable for any damages whatsoever (including, without limitation, damages for loss of profit, business interruption, loss of business information, or any other pecuniary loss) arising out of the use or inability to use this product.
